**WHAT DOES THE APMLE TEST? AND WHY?**

Podiatric medical students are exposed to many and varied topics during their education and on their path to independent practice. The objective of the American Podiatric Medical Licensing Examination (APMLE) series is to sample their knowledge of those areas that are deemed most significant and relevant to safe, effective practice. This is accomplished in a carefully planned process.

Whether the subject is lower extremity anatomy or surgical procedures and hospital protocol, all questions and tests are tied back to a recent study of what podiatrists do and what they must know. This study is called a practice analysis and is conducted at five-year intervals for the Part I and II examinations, and separately for the Part III test. The practice analysis is a national survey that asks podiatrists what tasks they do, what knowledge they must have to do the task, and how important the task is to safe, competent practice. The survey form and the test specifications that are designed from the results are developed by a group of practitioners under the guidance of testing and measurement experts. Only the tasks and topics that meet established criteria in a ranking of importance are included.

When individual test items are drafted, a review session is held to determine whether the item is appropriate and relevant to practice. Further, every question must be linked to a specific line in the test specifications. Review sessions include both practitioners and faculty for items in Part I and II tests, and are done entirely by practitioners for Part III.
