### **Annual Board Elections Held**

The NBPME held the election of officers at its annual meeting in Las Vegas, in July. Dr. Wayne Axman was elected as president, succeeding Dr. Charles Lombardi. Dr. Roy Corbin was elected vice-president and Dr. Jonathan Haber was elected treasurer. Their terms will run until the annual meeting in 2014.

### **Alyssa Stephenson, DPM, Welcomed to Board**

The NBPME is pleased to announce that Dr. Alyssa Stephenson has been appointed to join the board. She will replace Dr. Mindy Benton, who served her full term of nine years. Dr. Stephenson graduated from Scholl College and completed a three year podiatric surgical residency in Michigan with an additional traumatology rotation at Womack Army Hospital in North Carolina. She practices at Agnesian Health Care in Wisconsin. She is a Diplomate in ABPS and has served the profession in a variety of roles.

Wayne Axman, DPM, president of the NBPME stated that the board was pleased to have a physician of Dr. Stephenson's caliber and professional dedication join the board. Dr. Stephenson expressed her pleasure at being selected and said she looked forward to the opportunity to make a contribution to the board and to the profession.



### **NBPME Adopts Patient Encounter Exam**

After more than three years of careful study, including administering two pilot tests, the National Board agreed to institute a clinical skills patient encounter (CSPE) examination as a component of the Part II. The test will be required of fourth year students beginning with the Class of 2015. The first administration will be in August 2014 so scoring can be completed and an opportunity for retake offered prior to the residency match date the following winter.

A committee comprised of board members, practitioners and members of faculty has worked with the Clinical Skills Evaluation Collaborative, an agency of the NBME and ECFMG that is responsible for a similar examination for allopathic candidates. Discussions included detailed reports from CSEC testing specialists on the outcomes of the two pilot examinations.

The board adopted a policy that the first administration would be held at CSEC facilities in Philadelphia, and the fee will be \$1,230. Dr. Wayne Axman, board president, said the board chose to strike an appropriate balance that recognizes the need many candidates will have to travel to the test, but ensures adequate confidence in the scoring, which is best served by using only one test center, as is done in the osteopathic examination. He also emphasized that, while the fee is higher than the other parts of the APMLE series, it is comparable to the fee for the allopathic examination, and does not cover the entire actual cost.

Dr. Charles Lombardi, chair of the board's CSPE committee, said he was pleased with the progress on this initiative and that he believed it was a major step for the profession.
